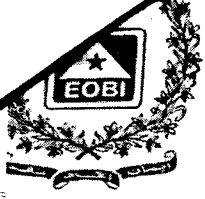

The Security Company should be registered with Income Tax Authorities (in the Active Taxpayers' List), Sales Tax, PRA and EOBI etc. (the bidder should attach copy of their necessary documents along with the request for tender).
